PRESIDENCY OF THE REPUBLIC

PRESIDENTIAL DECREE NO. (4) FOR THE YEAR 2006

ESTABLISHMENT AND COMPOSITION OF THE NATIONAL COUNCIL FOR THE COORDINATION OF DISARMAMENT, DEMOBILIZATION AND REINTEGRATION

President of the republic,

In accordance with the provisions of Article 58 (1) (m) and Article 225 of the interim constitution of the Republic of the Sudan for 2005 and, after perusal of the Presidential Decree No. 34/2005, I hereby issue the following Decree:

Title and Commencement:

- 1- This Decree may be cited as "Provisional Decree No. 4 for 2006 for the establishment and composition of the National Council for the Coordination of Disarmament, Demobilization and Reintegration", and shall come into force as of the date of its signature.

Interpretations:

- 2- In this Decree, and unless otherwise stipulated, the following words shall have the meanings set against each of them:
'Council': means the National Council for the Coordination of Disarmament, Demobilization and Reintegration.
"Commissions": means commissions of DDR in the North and the South

Composition:

The Council shall be composed of the following:

Competencies:

4-(1) The Council shall have the following competencies:

a- Approval of DDR policies presented to it by concerned quarters.

b- Set up Reintegration policies and supervising the implementation of those policies in collaboration with the concerned quarters.

c- Review and evaluation of progress made in the workings of Commissions and coordination of inter-commission work.

d- Raising regular reports to the Presidency of the Republic

(2) The Council shall be accountable to the Presidency of the Republic.

5-Meetings:

The Council shall meet regularly once every six months. The Chairman may call the Council for emergency meetings or, upon the request of half its membership.

6-Establishment of a Secretariat:

The Council may appoint a Secretariat for the purpose of documentation of its deliberations and resolutions and, the

following up of their implementation under the supervision of
the Chairman.

7-Budget:

The Ministry of Finance and National Economy, GoNU and the
Ministry of Finance, GoSS are to provide the necessary funding
for the Council.

8- Seat

The seat of the Council shall be in Khartoum, and may convene
in any place.

9-Rules

The Council may issue rules to regulate the running of its work.
